

I. The Institute's vision

Nowadays in our globalized world such relationship carries as many opportunities as challenges which young generations, both European and Arab, are called to face, by sharing and showing attitudes and concerns characterized by a common fund of feelings inclined either to change and conservation.

In this unique historical conjuncture, time has come to intensify exchanges and relations in view of an Euro-Arab consensus as a key-factor for reaching not only a greater and better understanding between cultures, but also more realistic prospects and targets of social progress and economic growth in terms of sustainable development of the entire Euro-Arab Region as central to the equilibrium of international relations worldwide.

III. The Institute's setting

In the aim to reach the largest audience of people and attract intellectual resources from all over interested quarters, the Institute is committed to promote a "Global Partnership" open to membership from a variety of countries, with involvement of entities (such as institutions, foundations, organizations) sharing common views and objectives as regards to peace, justice and security, finalized to the establishment of a true international academic community of researchers, scholars and students, working together for the progress of the university studies in the field of peace, justice and security.

In pursuance of the above statements, the Institute will pursue the following:

Aims & Tasks:

Proposed Activities:

In order to carry out its tasks the Institute will support and empower:

In general,

- Post-graduate courses/teachings in the fields of peace, sustainable development, human security, cultural diversity and dialogue, inclusion and integration, promoting diplomacy, global citizenship, people-to-people relations, cultural heritage, and poetic creativity;
- Research and scientific activities in these fields and related matters;
- Collection and arrangement of a special library on peace development studies;
- Promotional initiatives (conferences, seminars) aimed to the developing and dissemination of the above mentioned activities;
- Scholarships to help students and professors mobility;
- Any other activity useful in the aim to spread a culture of dialogue among peoples.

In particular,

- Regular periodic (yearly) lectures to be held in the name of the "Al Babtain Chair for Peace") at universities;
- Al "Babtain Scholarships on Peace Studies" for students and/or young researchers from Middle East and Mediterranean countries, to be used for periods of study and/or research at universities;
- Placement of books and other printed materials (libraries) in special sections dedicated to Arabic studies at universities.
